This initiative has led to measurable recovery, earning national recognition from the U.S. Environmental Protection Agency (EPA).

CNMI DPS POLICE SERGEANT DAVID M. HOSONO COMPLETES PRESTIGIOUS DHS LEADERSHIP ACADEMY

The Commonwealth of the Northern Mariana Islands (CNMI) Department of Public Safety (DPS) proudly announces that Police Sergeant David M. Hosono has successfully completed the 21st session of the U.S. Department of Homeland Security Leadership Academy (DHSLA). Held from January 6-16, 2025, at the Federal Law Enforcement Training Center (FLETC) in Glynco, Georgia, this prestigious program brings together senior law enforcement executives and command-level staff from across the nation for an intensive two-week curriculum focused on crisis leadership and resilience. Sergeant Hosono's participation in the DHSLA reflects CNMI DPS's commitment to strengthening leadership capabilities and enhancing public safety strategies.

INCIDENT COMMAND SYSTEM (ICS) & EMERGENCY OPERATIONS CENTER (EOC) TRAINING

From January 14 to 17, 2025, the CNMI Homeland Security and Emergency Management hosted the G-191 and G-2300 training courses with 36 participants in the G-191 and 32 participants in the G-2300 course. Attendees included representatives from the Commonwealth Healthcare Corporation (CHCC), the Department of Fire and Emergency Medical Services (DFEMS), the Bureau of Environmental and Coastal Quality (BECQ), and the Department of Defense (DoD).

G-191 focused on improving the interface between Incident Command and Emergency Operations Centers (EOCs) using National Incident Management System (NMIS) principles. G-2300 emphasized understanding the managerial roles and functions of modern EOCs within a Multi-Agency Coordination Group (MACG).
